## **ELIGIBILITY & CANDIDACY NOTES**

- 1 Candidates for this position must reside within the Oamaru Licensing Trust area, must be a New Zealand citizen and enrolled as a NZ parliamentary elector.
- Both nominators **must** be enrolled as electors of the Oamaru Licensing Trust.
- The candidate cannot be disqualified by the provisions of section 322 (1) of the Sale and Supply of Alcohol Act 2012 which states: A person is disqualified from election or appointment as a member of a licensing trust if he or she—
  - (a) is not a residential elector of the trust district or, in the case of the election or appointment of any member for a ward of a divided trust district, is not a residential elector entitled to vote at elections of members for that ward:
  - (b) has (directly or by virtue of his or her relationship with another person) such an involvement or appearance of involvement with the alcohol industry that he or she could not perform the duties of a member of a licensing trust without actual bias or the appearance of bias.
- 4 No person can be elected to a local authority if he/she is concerned or interested in contracts over \$25,000 with that local authority. This restriction is waived if prior approval from the office of the Controller and Auditor-General is obtained.
- A candidate **cannot** nominate themselves for office.
- Under section 121 of the LEA, any person is liable to a fine of up to \$2,000 who:
  - (a) Knowing themselves to be ineligible for election, consents to being nominated for election; or
  - (b) Nominates any person as a candidate whom he/she knows to be ineligible for election; or
  - (c) Not being the candidate signs any nomination paper knowing that they are not qualified to vote at the election.
- A candidate may, in accordance with section 61 of the LEA and clauses 26 to 29 of the LER, provide a candidate profile statement and/or a recent photograph for dispatch to electors with the voting documents.
