- *Government is funding development ie sewerage extensions. WDC should use this to provide areas ie - Parsons rd - Homestead Rd, Awamoa. to allow for smaller sections.*

Objective/Policy/Rule/Standard ref: *Rural - new minimum 20Ha.*

Comments: *Totally excessive, most do not have the equipment to farm this efficiently. Zoning is up to 3 Km from town boundary 6000sqm² to 2 Ha., 3 Km to 10 Km, 2 Ha to 4 Ha, 10 Km + 4 Ha.*
