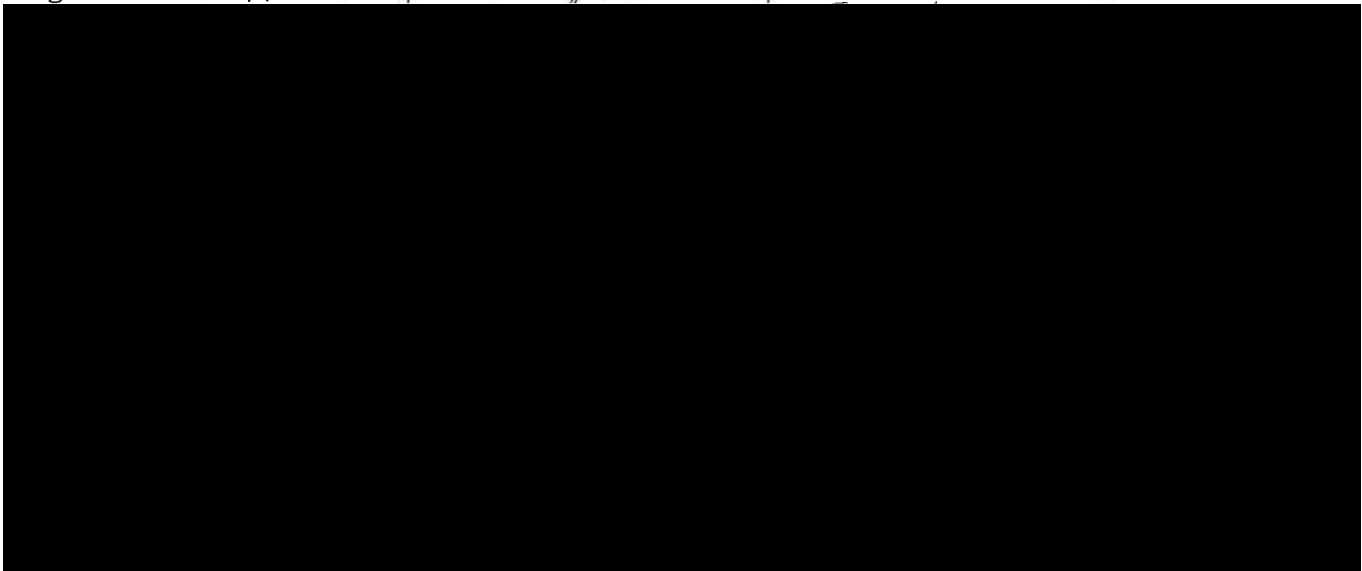

Comments: This should be removed, instead recommended to builder/developer to meet as much of 1-3 as practice when applying for consent to build. If we make rule as proposed we risk building homes with dark/cold living areas just to get a street look.

Objective/Policy/Rule/Standard ref: Frontage fencing (GR2-S9)
Comments: This proposed rule should be scrapped and replaced with something that helps protect pedestrian, cyclist and vehicle safety. Any new vehicle crossings to have no fencing higher than 0.9m up to 3 metres either side, in return Council will enforce no parking within 6 metres of all vehicle crossings. Existing fencing should apply otherwise.

I note that (new build) not mentioned but would apply. This also means that if you replace existing fence or hedge it applies. This also deprives your right to private enjoyment of your section. No provision for corner or more than one frontage!
