THIS MAP IS PROPOSING TO HAVE 3400 ACRE OF OUR PROPERTY IN FLOOD HAZARD ZONE OR IN LIQUEFACTION SUSCEPTIBILITY AREA. I FIND IT quite INTERESTING TO SEE THE NORTHERN BOUNDARY OF THIS AREA PROPOSED STOPS AT MY BOUNDARY

FENCE WITH A HIGHLY INTENSIFIED IRRIGATED DAIRY FARM. THIS IS PRETTY MUCH THE CASE WITH THE LIQUEFACTION SUSCEPTIBILITY AREA ALSO. ON ALTITUDE READINGS PARTS OF PROPERTY NEXT DOOR ALONE WITH TO TOWNSHIP OF OMARAMA, SHOULD ALSO BE IN THIS FLOOD ZONE ALSO. THERE ARE AT LEAST 4 HOUSES NORTH OF THE FLOOD ZONE LAND AT SAME LEVEL??

FOR THE AHURIRI RIVER TO FLOOD THIS PROPOSED ZONE, THE CHAIN HILLS WOULD HAVE TO GROW SEVERAL KILOMETRES AND JOIN THE BIG OMAR RANGE. SHOULD THE FLOOD ZONE BE WHERE THE FLOODING IS???








