#### Recommendation

Background

The costs of holding this event were estimated to be around \$2,000 and the Committee verbally approved this expenditure. Option 2 is not preferred as this is contrary to the verbal approval of the Committee and would create a shortfall in funding for payment of the creditors.

#### Conclusion

The Committee should agree the recommendation as they had verbally agreed to fund the Family Day up to \$2,000 and the actual costs were less than that amount and the funds are available.
