During the ensuing discussion, the following key points were clarified / agreed:

- The word "enhancing" should be used instead of "beautifying" in recommendation 1(a), because it had a wider application.
- The overall plan for the precinct and harbour area would include provision for parking.
- The Urban Park concept had been discussed previously, so it was timely to get something
  in front of the Committee to better inform decisions about what was required and what
  would be fit for purpose, and to discuss with stakeholders.
