Waitaki District Council has prepared a Summary of Decisions Requested for submissions to the Waitaki Proposed District Plan (PDP) and is now calling for Further Submissions under Schedule 1 (Part 1, Clause 8) of the Resource Management Act 1991.

Who can make a Further Submission?

A further submission may only be made by a person who:

- Represents a relevant aspect of the public interest; or
- Has an interest in the proposal that is greater than the interest the general public has; or,
- Waitaki District Council itself.
