

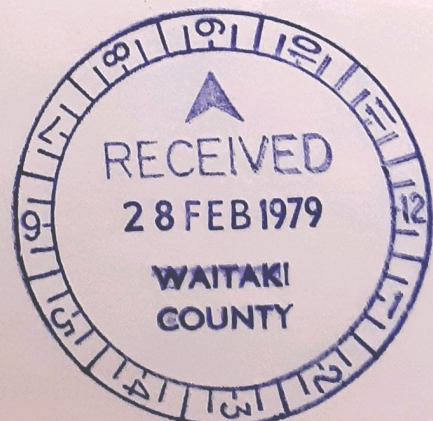
I refer to your 5/8 letter of 30 January 1979 and subsequent telephone conversation with Mr Budd.
