DECISION – ON PAPERS

This is an application by Macrae's Collie Club for a Special Licence in respect of premises situated at Moonlight Road Macraes known as "**Macraes Collie Club**".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

Alcohol may be sold and supplied under the licence only on the following days and during the following hours: Sunday 18 February 2024 from 12.00 midday to 2.00pm and 4.00pm to 10.00pm.

1. **MANAGEMENT:** A Certified Manager, Daniel Clarkson, shall be present on the premises and on duty for the duration of this event.
2. **FOOD:** Food will be provided in the form of donated food including savouries, sandwiches, baked goods, meat, salads and BBQ food.
3. **NON AND LOW ALCOHOL DRINKS:** An adequate supply of non-alcoholic and low-alcoholic beverages including juice, soft drinks, tea, coffee and low-alcohol beer shall be readily available.
4. **WATER:** Drinking water must be freely available to customers. Signage advertising the location of this free water shall be displayed.
5. **DESIGNATED AREAS:** For the period of the event, the premises will be undesignated.
6. **SIGNAGE:** Signage is required to be displayed stating that alcohol will not be served to any intoxicated person, alcohol will not be served to minors under the age of 18 years and ID is required. The statutory provisions preventing sale and supply of alcohol to prohibited persons must be enforced for the duration of the event.
7. **TYPE OF ALCOHOL:** Only beer, cider, and spirits to be sold.
8. Noise should be controlled so as not to disturb neighbouring residents.

9. **TRANSPORT:** The organisers must be proactive in promoting non-drink driving.
A phone shall be available for the ordering of alternative transport as may be required.
Signage advising of this assistance shall be displayed.
A courtesy car and driver shall be available if required.
10. **DISPLAY OF LICENCE:** This licence shall be displayed in a prominent public position at the principal entrance to the premises and at each point of alcohol sales.

In terms of s.142 (g) and (i) of the Act the premises, situated at Moonlight Road Macraes are more precisely identified in a plan dated as accepted by the District Licensing Committee on **5 February 2024**.
