DECISION – ON PAPERS

This is an application by Harbour Street Jazz Incorporated for a Special Licence in respect of premises situated at Harbour Street, Oamaru known as “**The Grainstore**”.

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

Section 147 (3) - Compulsory conditions

- (a) Alcohol may be sold under the licence only on the following days and during the following hours:
- **Friday 22 March 2024 and Saturday 23 March 2024 from 4.30pm to 11.00pm**
- (b) Drinking water will be freely available from the bar. As specified in the application.

Section 147 (1) - Discretionary conditions

- The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- Food must be available for consumption as specified on the application. Yuju is named as the provider of Sushi, fried chicken, dumplings etc. Food must be available at all times alcohol is being sold or supplied.
- Low-alcohol beer and lower alcohol wine must be available for sale and supply.
- Non-alcoholic beer and juices must be available for sale and supply on the premises.
- The licensee must provide assistance with or information about alternative forms of transport from the premises as specified in the application. The name and phone number of local taxi companies must be clearly displayed.
- A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application.

The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:

- (a) Noise should be controlled so as not to disturb neighbouring residents.
- (b) The premises are to be vacated within 30 minutes of the time at which the premises are required to be closed for the sale of alcohol.
- (c) An exemption from having a certified manager on duty is granted subject to Shona McMillan and Mary-Ann Hanrahan-Beets being responsible for the sale of alcohol.

In terms of s.142 (g) and (i) of the Act the premises, situated at Harbour Street, Oamaru are more precisely identified in a plan dated as accepted by the District Licensing Committee on **6 March 2024**.
