DECISION – ON PAPERS

This is an application by Frances Hope McMillan for a Special Licence in respect of premises situated at 1 Severn Street, Oamaru 9400 known as "**Settlers Theatre**".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

1. **DAYS AND HOURS:** Wednesday 10 April from 7.00pm to 11.30pm.
2. **MANAGEMENT:** The Manager appointed must be present on the premises and on duty for the duration of this event. Alice Hore is appointed as Manager.
3. **FOOD:** Food must always be continually, and readily available when alcohol is being supplied or sold. Food will be provided in the form of pies, pizza, and ramen noodles.
4. **NON AND LOW ALCOHOL DRINKS:** An adequate supply of non-alcoholic and low-alcoholic beverages including water, ginger beer, and Lemon, Lime and Bitters will be available.
5. **WATER:** Drinking water must be freely available to customers. Signage advertising the location of this free water shall be displayed.
6. **DESIGNATED AREAS:** The premises as a whole will be designated as: Supervised.
7. **SIGNAGE:** Signage is required to be displayed stating that alcohol will not be served to any intoxicated person, alcohol will not be served to minors under the age of 18 years and ID is required. The statutory provisions preventing sale and supply of alcohol to prohibited persons must be enforced for the duration of the event.
8. **TYPE OF ALCOHOL:** Only beer, wine and cider to be sold.
9. **EXCLUSIONS:** Only organisers, special guests and ticket holders shall be permitted on the premises
10. **TRANSPORT:** A phone shall be available for the ordering of alternative transport as may be required. Signage advising of this assistance and the telephone numbers of local taxi companies shall be displayed.

11. **DISPLAY OF LICENCE:** This licence shall be displayed in a prominent public position at

the principal entrance to the premises and at the point of alcohol sales.

In terms of s.142 (g) and (i) of the Act the premises, situated at 1 Severn Street Oamaru 9400 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **15 March 2024**.
