## **DECISION - ON PAPERS**

This is an application by Oamaru Club Incorporated for a Special Licence in respect of premises situated at 32 Severn Street Oamaru 9400 known as "Oamaru Club Incorporated".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

1. Alcohol may be sold under this licence only on the following days and during the following hours:

Live Wire Band

Saturday 11 May 2024 from 7.00pm to 12.30 am the following day.

Totally 80's Band Saturday 15 June 2024 from 7.00pm to 12.30 am the following day

- 2. The nominated managers must be present throughout the entire period of operation that pertain to the hours of the Special Alcohol Licence, to ensure the requirements of the Act in relation to the sale of alcohol to prohibited persons are observed. Nominated managers: Jennifer Robyn Baylis, Heather Ormandy, Wilailack Goldie.
- 3. The nominated managers may not partake in the consumption of alcohol for the duration of the event.
- 4. A comprehensive range and substantial amount of food is available for all in attendance. The approved menus or a minimum of at least three types of food such as Paninis, sandwiches, wedges, pies, pizzas, filled rolls or salads must be available for the entire duration of the licence.
- 5. Non-alcohol drinks available include a range of 10 post mixes, water to tables and available at the bar, fruit juices, Lemon, Lime & Bitters, Ginger Beer and zero percent wine and beer.
- 6. Drinking water must be freely available at the bar throughout the duration of the event.

- 7. No persons under the age of 18 may be sold alcohol but may be supplied by their parent or guardian.
- 8. The applicant must become fully aware of their obligations as the licensee under the Sale and Supply of Alcohol Act 2012.
- 9. The organisers must be proactive in promoting non-drink driving and display appropriate signage adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- 10. The licensee must take steps to provide assistance with or information about alternative forms of transport from the premises. The local taxi phone numbers must be displayed prominently, and the courtesy van must be available throughout the period of the special licence as stated in the application.

In terms of s.142 (g) and (i) of the Act the premises, situated at 32 Severn Street Oamaru 9400 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **19 March 2024**.
