DECISION – ON PAPERS

This is an application by Dunback Bowling Club for a Special Licence in respect of premises situated at Domain Road Dunback 9483 known as “**Dunback Bowling Club**”.

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

1. ALCOHOL may be sold under the Special Licence only on the following days and hours:
Thursday 25 April 2024 from 11.30am to 4.30pm
2. MANAGEMENT: The nominated managers must be present throughout the entire period of operation that pertain to the hours of the Special Alcohol Licence, to ensure the requirements of the Act in relation to the sale of alcohol to prohibited persons are observed. Nominated managers: Sandra Chapman, Glenn Baker.
3. The nominated managers may not partake in the consumption of alcohol for the duration of the event.
4. FOOD: Food must be continuously provided in the form of sandwiches, fruit loaf, savouries and biscuits.
5. NON AND LOW ALCOHOL DRINKS: An adequate supply of non-alcoholic and low-alcoholic beverages including juice, soft drinks, tea, coffee, and low-alcohol beer shall be readily available.
6. WATER: Drinking water must be freely available to customers at the following places: Bar, kitchen and from the water cooler centrally located in the hall.
7. Signage advertising the location of this free water shall be displayed.
8. DESIGNATED AREAS: The following parts of the premises is designated as:
Entire premises: undesignated.

9. **SIGNAGE:** Signage is required to be displayed stating that alcohol will not be served to any intoxicated person, alcohol will not be served to minors under the age of 18 years and ID is required. The statutory provisions preventing sale and supply of alcohol to prohibited persons must be enforced for the duration of the event.
10. **TRANSPORT:** A phone shall be available for the ordering of alternative transport as may be required. Signage advising of safe transport options must be displayed.
11. **DISPLAY OF LICENCE:** This licence shall be displayed in a prominent public position at the principal entrance to the premises and at each point of alcohol sales.

In terms of s.142 (g) and (i) of the Act the premises, situated at Domain Road Dunback 9483 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **26 March 2024**.
