DECISION - ON PAPERS

This is an application by Dunback Bowling Club for a Special Licence in respect of premises situated at 23 Domain Road Dunback 9483 known as "**Dunback Bowling Club**".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

- 1. ALCOHOL: May be sold under the Special Licence only on the following days and hours. Friday 25th April 2025 from 11.00am to 4.00pm.
- MANAGEMENT: The Managers appointed for the event must be present on the premises and on duty for the duration of this event. Sandra Chapman and Glen Baker are the appointed Managers.
- 3. FOOD: Food must be continuously provided in the form of sandwiches and biscuits.
- 4. NON AND LOW ALCOHOL DRINKS: An adequate supply of non-alcoholic and low-alcoholic beverages including juice, soft drinks, tea, coffee, and low-alcohol beer shall be readily available.
- 5. WATER: Drinking water must be freely available to customers at the following places: Bar and kitchen. Signage advertising the location of this free water shall be displayed.
- 6. SIGNAGE: Signage is required to be displayed stating that alcohol will not be served to any intoxicated person or to minors under the age of 18 years. ID is required from anyone looking under 25 years of age. The statutory provisions preventing sale and supply of alcohol to prohibited persons must be enforced for the duration of the event.
- 7. TRANSPORT: A phone must be available to call for an alternative transport if required. Signage regarding safe transport options must be displayed.
- 8. DISPLAY OF LICENCE: This licence must be displayed in a prominent public position at the principal entrance to the premises and at each point of alcohol sales.

In terms of s.142 (g) and (i) of the Act the premises, situated at Domain Road Dunback 9483 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **27 March 2025**.
