**DECISION – ON PAPERS**

This is an application by Penguin Entertainers Club for a Special Licence in respect of premises situated at Penguin Club, 10 Harbour Street, Oamaru 9400 known as **"Penguin Club Incorporated"**.

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.


We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

1	Alcohol may be sold under the licence only on the following days and during the following hours: Saturday 21 May 2022, Saturday 28 May 2022, Friday 3 June 2022, Saturday 4 June 2022, Saturday 18 June 2022, Saturday 16 July 2022, Saturday 20 August 2022, Saturday 17 September 2022, Saturday 22 October 2022 and Saturday 19 November 2022 from 7.00pm to 11.30pm.
2	One of the nominated managers must be present throughout the entire period of operation that pertain to the hours of the Special Alcohol Licence, to ensure the requirements of the Act in relation to the sale of alcohol to prohibited persons are observed. Nominated managers: David John Snow, Mark Gibbins, Jamie Bedford.
3	The nominated managers may not consume alcohol for the duration of the event if they are the appointed manager and present for the event.
4	The applicant shall provide adequate security to ensure that no intoxicated persons are permitted entry to the venue.
5	A comprehensive range and substantial amount of food must be available for all in attendance. The approved menu, or a minimum of at least three types of food such as Paninis, sandwiches, wedges, pies, pizzas, filled rolls or salads must be available for the entire duration of the licence.
6	A suitable range of low alcohol and non-alcoholic beverages must be provided.
7	Drinking water to be freely available at the bar while the premises are open for business.
8	The sale of food must be strictly in accordance with the relevant requirements of the Food Hygiene Regulations 1974.
9	No persons under the age of 18 may be sold alcohol but may be supplied by their parent or guardian.
10	The applicant remains fully aware of their obligations as the licensee under the Sale and Supply of Alcohol Act 2012.

11	The organisers must be proactive in promoting non-drink driving and display appropriate signage adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
12	The licensee must take steps to provide assistance with or information about alternative forms of transport from the premises, including the contact details of a local taxi company.
