DECISION – ON PAPERS

This is an application by North Otago Rugby Football Union Incorporated for a Special Licence in respect of premises situated at Taward Street Oamaru North Oamaru 9400 known as "**Whitestone Contracting Stadium**".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

Section 147 (3) - Compulsory conditions

- (a) Alcohol may be sold under the licence only on the following days and during the following hours: 15 July 2023, 29 July 2023, 19 August 2023, 2 September 2023, 9 September 2023, 23 September 2023, 7 October 2023, 14 October 2023, 15 October 2023, 4 November 2023 from 12.00 noon to 6.00pm.
- (b) Drinking water must be freely available while the premises are open for the sale and supply of alcohol in the Corporate Area, Public Bar, and the bar under the Grandstand.

Section 147 (1) - Discretionary conditions

- a) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- b) Food must be available for consumption on the premises at all times alcohol is being sold or supplied. A comprehensive range and substantial amount of food must be available for all in attendance. Pita Pit Platters, pizza's Subway Platters, hot dogs, hot chips, and BBQ food or a minimum of at least three types of food such as Paninis, sandwiches, wedges, pies, pizzas, filled rolls or salads must be available for the entire duration of the licence.
- c) Low-alcohol beer (Steinlager Mid and Speights Mid) must be available for sale and supply on the premises.

- d) Non-alcoholic beverages such as water, orange juice, and cans of soft drink must be available for sale and supply on the premises throughout the special event.
- e) The licensee must provide assistance with or information about alternative forms of transport from the premises as specified in the application. The name and phone number of the local taxi company must be clearly displayed.
- f) A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- g) Members of the public must be excluded from the premises in the following circumstances:
- h) Entry is restricted to ticket holders only in the Corporate area.
- i) Glass containers are prohibited. In the Corporate area - all drinks from glass containers must be poured by bar staff into plastic glasses. On the rest of the site only cans and plastic glasses may be sold.
- j) Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application.
- k) Management: Certified Manager Faye Allan, shall be present on the premises and on duty for the duration of this event.

The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:

- (a) Noise should be controlled so as not to disturb neighbouring residents.
- (b) **A maximum of 2 alcoholic drinks may be sold to one patron at a time.**

In terms of s.142 (g) and (i) of the Act the premises, situated at Taward Street Oamaru North Oamaru 9400 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **10 July 2023**.
