**DECISION – ON PAPERS**

This is an application by Oamaru Club Incorporated for a Special Licence in respect of premises situated at 32 Severn Street Oamaru 9400 known as "**Oamaru Club Incorporated**".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

Section 147 (3) - Compulsory conditions

(a) Alcohol may be sold under the licence only on the following days and during the following hours:

**DND Showcase – "It's the 80's Show.**

**Saturday 12 August 2023 from 6.00pm to 12.00 midnight**

(b) Free iced water is freely available from a large water container and glasses on the Bar as specified in the application. Water is also available through the post mix taps.

Section 147 (1) - Discretionary conditions

- a) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- b) Food must be available for consumption on the premises at all times the premises are open for the sale of alcohol. The application states food is available from the Bar Menu or Full Menu.
- c) Low-alcohol beverages must be available for sale and supply on the premises.
- d) Non-alcoholic beverages must be available for sale and supply on the premises. Fruit juice, Post Mix soft drinks and iced water is specified in the application.
- e) The licensee must provide assistance with or information about alternative forms of transport from the premises. A courtesy van must be available, and the name and phone number of the local taxi company must be clearly displayed.

- f) A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- g) Entry is restricted to ticket holders only.
- h) Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application.

Section 147 (2) - Restricted and supervised areas

The following area is designated as an undesignated area – Sports Hall and Members Bar

Restricted: Gaming Room

In terms of s.142 (g) and (i) of the Act the premises, situated at 32 Severn Street Oamaru 9400 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **25 July 2023**.
