DECISION – ON PAPERS

This is an application by Otago Racing Club Incorporated for a Special Licence in respect of premises situated at Pukeuri-Hilderthorpe Road, Oamaru known as “**Oamaru Racecourse**”.

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

1. Alcohol may be sold under the licence only on the following days and during the following hours: 8/09/2023, 19/10/2023 – 11.00am to 6.00pm
2. The nominated manager must be present throughout the entire period of operation that pertain to the hours of the Special Alcohol Licence, to ensure the requirement of the Act in relation to the sale of alcohol to prohibited persons are observed. Nominated manager: Noelle Katherine Prince 69/CERT/063/2021
3. The nominated manager may not partake in the consumption of alcohol for the duration of the event.
4. A comprehensive range and substantial amount of food is available for all in attendance. An approved menu or a minimum of at least three types of food such as Paninis, sandwiches, wedges, pies, pizzas, filled rolls or salads must be available for the entire duration of the licence.
5. The sale of food be strictly in accordance with relevant requirements of the Food Hygiene Regulations 1974.
6. A suitable range of low alcohol and non-alcoholic beverages is provided.
7. Drinking water to be freely available at the kitchen and tables throughout the duration of the event.
8. No persons under the age of 18 may be sold alcohol but may be supplied by their parent or guardian.
9. The applicant becomes fully aware of their obligations as the licensee under the Sale and Supply of Alcohol Act 2012.
10. The organisers must be proactive in promoting non-drink driving and display appropriate signage adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
11. The licensee must take appropriate steps to provide assistance with or information about alternative forms of transport from the premises.

In terms of s.142 (g) and (i) of the Act the premises, situated at Pukeuri-Hilderthorpe Road, Oamaru are more precisely identified in a plan dated as accepted by the District Licensing Committee on **3 August 2023**.
