DECISION – ON PAPERS

This is an application by Kurow Rugby Club for a Special Licence in respect of premises situated at Loch Laird Road, Otematata known as "**Loch Laird Camping Area**".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

Section 147 (3) - Compulsory conditions

- (a) Alcohol may be sold under the licence only on the following days and during the following hours:
- **Friday 23 September 2022 and Saturday 24 September 2022 from 11.00am to 1.00am the following day**
- (b) Bottles of drinking water will be freely available on the premises as specified in the application.

Section 147 (1) - Discretionary conditions

- a) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- b) Food vendors and food stalls must provide food available for consumption on the premises throughout the period of the special event at all times alcohol is being sold or supplied.
- c) The appointed manager must be on site at all times alcohol is available for sale or supply.
- d) Low-alcohol beverages must be available for sale and/or supply on the premises.
- e) Non-alcoholic soft drinks, juices and tea, coffee beverages must be available for sale and/or supply on the premises. Bottled water must be provided for free as specified in the application.
- f) The licensee must provide assistance with or information about alternative forms of transport from the premises as specified in the application.

- g) A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- h) Members of the public must be excluded from the premises in the following circumstances:
 - i) Entry is restricted to ticket holders only, or those members of the public who have paid an entry fee to view the motorcycles on Saturday 24 September 2022.
 - j) Only the following kind or kinds of alcohol may be sold the premises: beer and RTD's.
 - k) Alcohol may be sold in the following types of container only: cans, plastic.
 - l) Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application.

The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:

- (a) Noise should be controlled so as not to disturb neighbouring residents.
- (b) A maximum of 4 alcoholic drinks may be sold to one patron at a time.
- (c) The Alcohol Management Plan, as provided with the application and the undertakings within, are to be read as conditions of the licence and must be adhered to.
- (d) This licence does not excuse the applicant from obtaining where necessary a Building Consent in respect of tents or marquees
- (e) Security guards shall be employed to ensure no alcohol is bought onto the site.

In terms of s.142 (g) and (i) of the Act the premises, situated at Loch Laird Road, Otematata 9412 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **13 September 2022.**
