DECISION - ON PAPERS

This is an application by Maheno School Trustees for a Special Licence in respect of premises situated at 192 Mount Misery Road Waianakarua 9495.

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

Section 147 (3) - Compulsory conditions

- (a) Alcohol may be sold under the licence only on the following days and during the following hours:
 - Saturday 11 November 2023 12.00pm to 7.00pm.
- (b) Drinking water will be freely available on the premises from multiple water dispensers throughout the location of the event.

Section 147 (1) - Discretionary conditions

EALDECSP Decision for Special Licence

- a) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- b) A certificate holding Manager shall be present on the premises and on duty for the duration of this event. Ross Munroe Hay is named Manager for the event.
- c) Food must be available for consumption on the premises throughout the period of the special licence when alcohol is available for purchase. BBQ food including burgers, sausages, salads and tacos are specified in the application.
- d) Low-alcohol beverages must be available for sale and supply on the premises. Heineken Light is specified in the application.
- e) Non-alcoholic beverages such as soft drinks, juices, water, and lemon, lime and bitters must be available for sale and supply on the premises as specified in the application.

- f) The licensee must provide assistance with or information about alternative forms of transport. The phone numbers of designated drivers and a free courtesy van must be available.
- A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- h) Only the following kind or kinds of alcohol may be sold: Beer, wine and RTD's.
- This license does not excuse the applicant from obtaining where necessary a Building Consent in respect of tents and marquees.

The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:

(a) Noise should be controlled so as not to disturb neighbouring residents.
