## **DECISION - ON PAPERS**

This is an application by Papakaio Squash Club for a Special Licence in respect of premises situated at 21 Papakaio Road Papakaio 9494 known as "Papakaio Squash Club".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

## Section 147 (3) - Compulsory conditions

- (a) Alcohol may be sold under the licence only on the following days and during the following hours:
  - Saturday 28 October 2023 from 5.00pm to 12.00 midnight
- (b) Drinking water will be freely available from the kitchen at the premises.

## Section 147 (1) - Discretionary conditions

- Mark Andrew Gibbons (Certified Manager) shall be present on the premises and on duty for the duration of this event.
- b) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- c) Food must be available for consumption on the premises as specified in the application. The dinner meal will consist of meat, coleslaw and buns, hot dogs, hot chips and pizza. Note: Substantial food items such as pies, savouries, sandwiches, paninis and similar must be available throughout the time alcohol is being sold or supplied.
- d) Low-alcohol beer (2% Export Citrus) must be available for sale and supply on the premises as specified in the application.
- e) Non-alcoholic beverages (soft drinks, zero percent beer and water) must be available for sale and supply on the premises as specified in the application.

- f) The licensee must provide assistance with or information about alternative forms of transport from the premises as specified in the application. A courtesy van must be available and promoted.
- g) A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- h) Members of the public must be excluded from the premises in the following circumstances:
- i) Entry is restricted to entrants to the championship tournament and their supporters only.
- j) Alcohol may be sold in the following types of containers only: glass, cans.
- k) Alcohol must only be sold, supplied and consumed within the area marked on the plan submitted with the application.

The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:

(a) Noise should be controlled so as not to disturb neighbouring residents.

In terms of s.142 (g) and (i) of the Act the premises, situated at 21 Papakaio Road Papakaio 9494 are more precisely identified in a plan dated as accepted by the District Licensing Committee on **25 October 2023**.
