## **DECISION - ON PAPERS**

This is an application by Lower Waitaki Golf Club Incorporated for a Special Licence in respect of premises situated at 26 Hilderthorpe Road Hilderthorpe 9493 known as "Lower Waitaki Golf Club".

Reports have been received from The Waitaki District Council Licensing Inspector, The New Zealand Police and The Medical Officer of Health.

Based on the information provided to us on the complete file, we have determined to grant the application on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act. We grant the applicant a special licence pursuant to s.22 of the Act.

The licence is approved and will be subject to the following conditions:

## Section 147 (3) - Compulsory conditions

- (a) Alcohol may be sold under the licence only on the following days and during the following hours:
  - Friday 17 November 2023 from 5.00pm to 12.00 midnight
- (b) Drinking water must be freely available on the premises from the bar as specified in the application.

## Section 147 (1) - Discretionary conditions

- a) The licence holder must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- b) The nominated manager must be present throughout the entire period of operation that pertain to the hours of the Licence, to ensure the requirements of the Act in relation to the sale of alcohol to prohibited persons are observed. Nominated manager: Gordon Greaney. The nominated manager may not partake in the consumption of alcohol for the duration of the event.
- c) Substantial food must be available for consumption on the premises throughout the period of the special licence. BBQ meats, salads and desserts are specified in the application.
- At least one low-alcohol beverage must be available for sale and supply on the premises.
  Heineken Light, Mid Ale and DB Citrus are specified in the application.

- e) Non-alcoholic fruit juices, water and soft drinks must be available for sale and supply on the premises.
- f) Transport to and from the premises will be provided for those attending.
- A copy of this licence, together with signs showing the age restriction must be clearly displayed.
- h) Members of the public must be excluded from the premises in the following circumstances:
- i) Entry is restricted to invited guests only.

In terms of s.142 (g) and (i) of the Act the premises, situated at 26 Hilderthorpe Road Hilderthorpe 9493 are more precisely identified in a plan dated as accepted by the District Licensing Committee on 6 November 2023.
