## **APPENDIX I**

## Settlement to Ngai Tahu by Office of Treaty Settlements

Changes proposed within the Waitaki District Council boundaries include:

- 1. The renaming of Shag Point Reserve. Matakaea Reserve
- 2. The vesting of two reserves, at Katiki and Takiroa, in Ngai Tahu (see maps).
- 3. Eight nohoanga or camping licences (see maps).
- 4. The remaining provisions (see maps and schedules) relate to the recognition of Ngai Tahu's cultural and historical associations with certain areas and access to food gathering areas. A description of the legal instruments used to achieve this follows below.

**Statutory Acknowledgements** – these will be included in the Settlement legislation and acknowledge the special association Ngai Tahu has with an area or site. These acknowledgements will be recognised in any proceedings under the Resource Management Act and the Historic Places Act.

**Topuni** – special areas which acknowledge Ngai Tahu's traditional cultural, spiritual and historic values and associations and require Ngai Tahu to be consulted as to appropriate permitted activities. Existing classifications, such as reserves, continue.

**Deeds of Recognitions** – sets out an agreement between the administering Crown body (the Minister of Conservation or the Minister of Crown Lands) and Ngai Tahu which recognises Ngai Tahu's special association with a site – as stated in a Statutory Acknowledgement – and specifies the nature of Ngai Tahu's input into the management of the site.

**Statutory Advisor** – Ngai Tahu can be appointed an adviser to the Minister of Conservation in relation to specific sites.

**Nohoanga** – a license to temporarily occupy or camp on a piece of land up to one hectare near a traditional Ngai Tahu food gathering area such as a river of a lake. It is set back from the marginal strip and does not impede public access to or along a waterway.

# None of the above classifications or instruments will apply to private land, they will only apply to Crown land.

Rename reserve, statutory acknowledgement, deed of recognition, Topuni and statutory adviser.

Vests as a reserve in Te Runanga o Ngai Tahu.

#### MS 24 – Katiki/ Te Raka a Hineatea

Vests as a reserve in the Te Runanga o Ngai Tahu.

Statutory acknowledgement and deed of recognition
