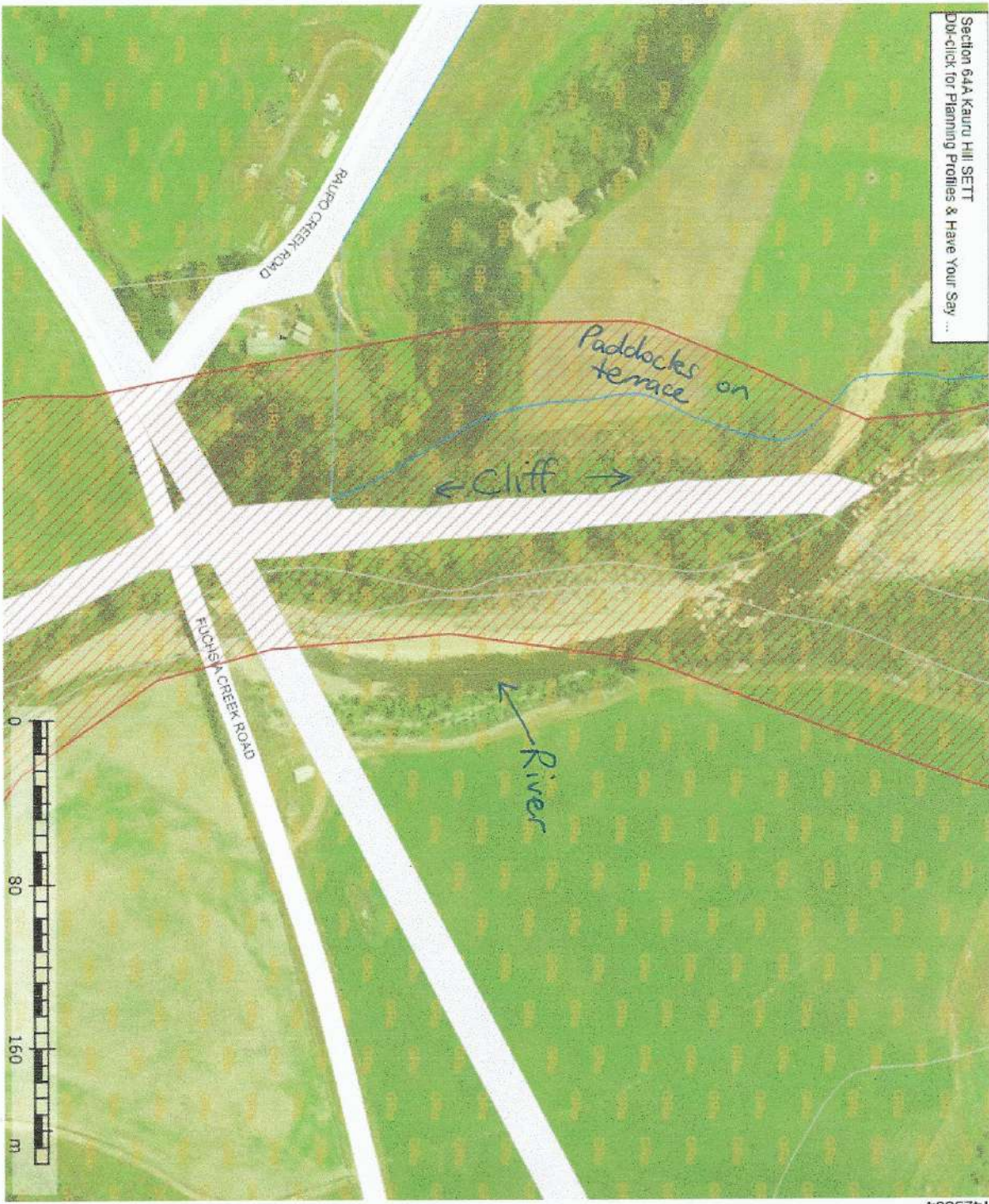

	Hi My name is Sarah Isbister and along with my family I have a beef finishing farm at 46 Raupo Creek Road, Five Forks. I have been looking at the district plan mapping and disagree with where the overlay for the Kakanui River has been placed on our property. I know the channel of a river can change significantly however the overlay on our farm shows that the river boundary is up a steep cliff in our paddocks on top of the terrace. While on the other side of the river boundary (where the river currently is) it isn't even within the overlay boundary. There is no way the river can be accessed through the paddocks on our farm due to the steep nature of the terrain. I would like the overlay to be realigned to be nearer to where the river actually is and also where it can be accessed if needed. I would prefer that a Site and Area of Significance to Maori or any other distinction isn't associated with our title if it doesn't have to be.
