

Official LGOIMA Response:

1. What is(are) the proposed source(s) of the proposed \$400,000 funding to be spent on an Adventure Playground in Omarama in years 2025 and 2026 of the LTP, and the ongoing funding as detailed in the list of initiatives to be included in the council's 10-year budgets? (Agenda item 7.1 February 27, 2024 council meeting as detailed below: In 2025, it is proposed \$208,080 will be spent on an adventure playground in Omarama. An amount of \$226,414 is set aside for spending on the adventure playground the following year. In the years that follow until 2034, \$37K to \$39K is to be set aside for the playground annually.)

The proposed \$400,000 funding to be spent on an Adventure Playground in Omarama in years 2025 and 2026 of the LTP is budgeted to be loan funded. The amounts in later years will be funded by rates.

The adventure playground was put forward as an option during the 2018/2019 masterplan process and we would have received feedback to support this as it was identified as the 5th most preferred option. The ranking was based on surveys and feedback received from the community workshops that were undertaken at the time. It was consequently identified as an option and included in the final masterplan map.




HERE'S A SNAPSHOT OF WHAT YOU TOLD US AT THE COMMUNITY WORKSHOP:

3. Has there been a needs analysis done for an adventure park/playground for Omarama? If so, could you please forward a copy.

No, we are not aware of any needs analysis that was carried out at the time.

4. The funds, as detailed in the AP/LTP proposal, appear to be ring-fenced for an adventure park. Why can these funds not be spent on reinstating the Omarama Sports field which has been listed as a community priority in visioning sessions, surveys and questionnaire responses since 2018?

Money has been set aside in the 2031 financial year for a Sports field in Omarama. If the community feels that priorities should change, then they will be able to do that through the Annual Plan / Long term engagement processes for council to consider.

5. Sports fields are funded across the district using district services charges – what proportion of these have been spent in Omarama on its sports field in the past five years?

No money has been spent on rates in the Omarama area within the last 5 years.

The Reserve Management Plan categorises Reserve types and their service levels. As Omarama is not classed as a sports field, it is not maintained as one and is not funded from the district sports ground rate.
