Council Officers reviewed the request with collated answers below. Documents and emails were also provided to the requester.

1. What funds have been provided to you related to the three waters proposal.

Stimulus funding - \$7.46M early on.

Better Off funding – WDC has been granted \$3,710,000 under the BOF programme. We have received a 10% advance of that sitting at \$370,000. The remaining funds are claimed by WDC as we go, based on the amount of money we have spent.

Working on Reforms – we received and recognised as income in 2023, of \$390k.

2. What funds are promised but not yet provided.

Stimulus funding – All received.

Better Off funding – WDC is still able to claim \$3,340,000 under the BOF programme.
