Please note that the stock crossing is to comply with the Code of Practice for Stock Crossings (refer to our website [www.waitaki.govt.nz](http://www.waitaki.govt.nz)).

### The frequency of stock crossing:

This is the number of crossings in any month. This is not an average over the milking season or year i.e. 40 times in one month equates to stock being moved to and from two milkings each day for ten days per month or a similar combination adding up to 40 times in one month.

The frequency of stock crossing will generally be assessed in terms of the proportion of grazing area on either side of the road being crossed. Accordingly, if 50% of the grazing area is across a road then it is assumed that at least 60 crossings per month will occur).

Where an applicant regards this approach as unsuitable, an alternative method shall be documented to support the application.
